

NOTICE OF SPECIAL ELECTION

NEW HAMPTON FIRE DISTRICT, IN THE
TOWN OF WAWAYANDA
ORANGE COUNTY, NEW YORK

NOTICE IS HEREBY GIVEN that a Special Election of the qualified voters of the New Hampton Fire District (hereinafter called the "Fire District"), in the Town of Wawayanda, Orange County, New York, will be held at the New Hampton Fire District Social Hall, 5024 Route 17M, New Hampton in the Town of Wawayanda, New York, in said Fire District, on Tuesday, February 11, 2020. The polls shall open at 6:00 o'clock P.M. (Prevailing Time) and shall remain open until 9:00 o'clock P.M. (Prevailing Time) or as much longer as may be necessary to enable the voters then present to cast their votes.

NOTICE IS HEREBY FURTHER GIVEN that pursuant to the resolution adopted by the Board of Fire Commissioners of the Fire District on December 23, 2019, the following Proposition will be submitted to the qualified voters of the Fire District for approval or disapproval:

PROPOSITION

SHALL the bond resolution of New Hampton Fire District, in the Town of Wawayanda, New York, entitled: "BOND RESOLUTION OF THE NEW HAMPTON FIRE DISTRICT ("FIRE DISTRICT"), IN THE TOWN OF WAWAYANDA, ORANGE COUNTY, NEW YORK, ADOPTED DECEMBER 23, 2019, AUTHORIZING THE ACQUISITION BY PURCHASE OF A PARCEL OF REAL PROPERTY LOCATED AT 5030 ROUTE 17M IN NEW HAMPTON, AND THE EXISTING BUILDING THEREON, FOR USE BY THE FIRE DISTRICT (THE "PROJECT"); STATING THE ESTIMATED MAXIMUM COST THEREOF IS \$400,000, INCLUDING PRELIMINARY COSTS AND COSTS INCIDENTAL THERETO AND TO THE FINANCING THEREOF; APPROPRIATING SAID AMOUNT FOR SUCH PURPOSE, INCLUDING THE APPROPRIATION OF NOT TO EXCEED \$150,000, HEREBY AUTHORIZED TO BE EXPENDED FROM THE EXISTING "CAPITAL RESERVE FUND FOR THE PURCHASE AND IMPROVEMENT OF REAL PROPERTY" HERETOFORE ESTABLISHED, TO BE APPLIED TOWARD SAID COST; AUTHORIZING THE ISSUANCE OF BONDS OF THE FIRE DISTRICT IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$250,000 TO FINANCE THE BALANCE OF SAID APPROPRIATION; DETERMINING THAT THE PERIOD OF PROBABLE USEFULNESS OF SAID REAL PROPERTY IS THIRTY (30) YEARS AND PROVIDING FOR THE LEVY OF TAXES TO BE COLLECTED TO PAY THE PRINCIPAL OF AND INTEREST ON SAID BONDS," BE APPROVED?

All residents of the Fire District who were duly registered to vote with the Orange County Board of Elections on or before January 21, 2020, shall be eligible to vote at said Special Election.
