**ORDER CALLING FOR
PUBLIC HEARING TO
CONSIDER APPROVING
INCREASE AND
IMPROVEMENT OF
FACILITIES**

WHEREAS, a map and plan has been prepared by competent engineers duly licensed by the State of New York in such manner and in such detail as determined by the Town Board of the Town of Wawayanda concerning the increase and improvement of facilities of the Arluck Water District; and

WHEREAS, the proposed improvements include exploration of the following alternative treatments to mitigate the existing elevated levels of perfluorinated chemicals recently found in the District's water source: (1) either the construction of an additional wellhouse to treat the existing contaminants or (2) the connection of the Arluck Water District facilities to the Denton Hills Water District facilities, which has not reported any perfluorinated chemicals. Both options are intended to reduce the concentration of perfluorinated chemicals and produce finished water with levels that meet the action level for perfluorinated contaminants in drinking water established by New York State.

WHEREAS, the estimated maximum cost of the higher cost alternative, which is connection of the Arluck Water District facilities to the Denton Hills Water District facilities, is \$2,094,750.00.

ORDERED, that the Town Board of the Town of Wawayanda will hold a special meeting for the purpose of a public hearing on November 16, 2021, at 7:00 PM, in person at the Wawayanda Town Hall, 80 Ridgebury Hill Road Slate Hill, New York to consider and hear public comments from all persons interested in the subject of a proposed increase and improvements of the facilities of the Arluck Water District as described above.

FURTHER ORDERED that the Town Clerk is hereby directed to publish notice of this So Ordered hearing at least once in the official newspaper of the Town not less than 10 nor more than 20 days before the date of the hearing, and be it

FURTHER ORDERED that the Town Clerk is hereby directed to cause a certified copy of this Order to be posted on the sign board of the Town not less than 10 nor more than 20 days before the date of the hearing.
